



ANNOUNCEMENT FOR THE INTERNATIONAL CONFERENCE:

“History of the Emergence of Nation-States in Turkic World and the Struggles for Independence in late 19th and early 20th Centuries”

CALL FOR PAPERS

2021 being the centennial of the foundation of Autonomous Soviet Socialist Republic of Kazakhstan, which is regarded as one of the important stages for the foundation process of independent Republic of Kazakhstan, an international conference entitled **“History of the Emergence of National States in Turkic World and the Struggles for Independence in late 19th and early 20th Centuries”** will be held online on April 16, 2021 organized by Al-Farabi Kazakh National University of the Republic of Kazakhstan and Atatürk Institute, Hacettepe University of the Republic of Turkey.

Developments from the second half of the 19th Century caused the emergence of deep-rooted changes in Turkey as well as the entire Turkic geography. These developments particularly in the fields of education and journalism paved a basis for the emergence of a new intellectual class in the Turkic world. Weakening and the dissolution of the Tsarist Russia through the World War I and its aftermath, made a sensation for independence among these pioneering intellectuals on the large Turkic landscape, covering the area from Caucasia, contiguous to Anatolia, to the borders of East Turkestan. New tendencies emerged in political, economic, demographic and social structures deeply affected all the peoples living in the referred geography.

The purpose of this conference is, on the occasion of the centennial of the foundation of Autonomous Kazakh Soviet Socialist Republic, to do a scholarly research on economic, political, social circumstances and gradual changes in Turkestan region in the referred period and therefore to make a contribution on the knowledge accumulation in historiography at international level.

Issues such as historical questions of national histories of the Kazakhs and other Turkic peoples, the Alash movement and “Alash” autonomy, foundation and activities of the Kazakh Autonomous Soviet Socialist Republic are going to be debated in the conference. Moreover, the conference also covers subjects such as the national struggle for independence of Turkic peoples from Anatolia to Turkestan geography in the late 19th and early 20th centuries as well as the role of the historical pioneers of these struggles.

TERMS FOR APPLICATION

In order to be included into the conference programme, the application form should be filled in and an abstract with 200-250 words both in English and Turkish should be sent to the Organization Committee in a Microsoft Office Word file. **The deadline for applications is March 10th, 2021.** The name of the file should include the author’s name (For example: Sadykova Ainur_abstract)

The conference paper should be prepared in one of the conference languages declared above. Nevertheless, the full texts of the papers will only be accepted in English or Turkish.

The selected abstracts among the applications should present the full texts of their conference papers around 6000-10.000 words (the full texts should not exceed 10.000 words in total) in English or Turkish with an abstract around 200-250 words in both languages to the Organization Committee **until April 1st, 2021 the latest.** Full texts of the conference papers should be sent as a Microsoft Office Word file to the following address: conference.kazassr@gmail.com The name of the Word file should be as these format: author’s name_konferans (for example: Sadykova Ainur_konferans). The file should only contain the text of one conference paper. The applicants commit to take the responsibility of the content of their own works. **A proceedings book with the full texts is going to be published soon.**

SPELLING RULES

1. In the study, the title should be capitalized with bold capitals, just below the author's name and surname. There should be the academic title, institution and e-mail adress in this specified order in the explanation footnote that will be placed under the page.
2. After the title and author name, a summary of 10 points-100 words- should be included in Turkish and English. The title should be given also in English. English and Turkish key words should be added.
3. The character should be **Times New Roman** and **the font size should be 12**. The point size of the tables, footnotes and resources should have a font size of 10.
4. The work must be in (.doc) or (.docx) format. In the page layout, it is required that there is 2,5 cm space from the bottom, top, right and left; 1,25 cm space should be provided for the sub-information and information.
5. Paragraphs should not have line gaps; indentation: 0 cm, space: first 6 pt - after 6 pt and the line gap should be one line.
6. References should be given in footnotes. The name and surname of the author, the title of the book (**bold capitals**) - the name of the article in quotation and the journal in which the article is published should be given in the order of publisher, publication place, date, number. The sources used should be put in an alphabetical order at the end of the text in the same format as the footnotes. The sample is given as follows:

7. Tables and graphs should be numbered separately; just below the table or graph, the source should be specified in 10 pt.
8. Original documents, pictures, maps and similar images not directly related to the text should not be included in the text unless necessary; should be numbered and attached at the end of the pictures if necessary.
9. The papers should be limited to 6-10 thousand words.
